

NOTICE OF SALE OF USED MOTOR VEHICLE, AUDI A6 2.0 TDI ULTRA

1. Sale by auction.

It is hereby announced that the Permanent Representation of Italy to the Atlantic Council, pursuant to Decree of the Permanent Representative to the Atlantic Council No. 9 of 19/12/2025, is selling by auction the following motor vehicle:

The motor vehicle, black in color, is equipped with an automatic transmission, replaced in 2025 by an authorized AUDI repair shop, and with two sets of tires (winter and summer) in excellent condition; it is also equipped with thermoregulated leather seats, satellite navigation system, alloy wheels, and keyless ignition system.

The auction will be held pursuant to Articles 73, letter c), and 76 of Royal Decree No. 827 of 23 May 1924, as amended and supplemented, in a single bidding round, by means of sealed bids exclusively increasing, to be compared with the starting auction price.

It is possible to inspect the vehicle by appointment to be requested at the email address: cont.natobruxelles@esteri.it by 12/01/2026. A road test is permitted upon written request; however, it will not be possible to drive the vehicle personally, as the car will be driven by the driver of the Permanent Representation. It is also possible to request photographs of the vehicle by sending an email to the above-mentioned address.

The vehicle in question will be offered for sale in its current state of fact and law. The vehicle is sold as is, and the purchaser may not raise any claims for any defects or malfunctions.

Any charges related to the ownership and use of the vehicle, in accordance with applicable regulations (any inspections, registrations, or other requirements), shall be borne by the purchaser.

The successful bidder shall be responsible for completing all formalities necessary for the transfer of ownership and for any other procedure related to the use of the vehicle, with no obligation on the part of the Permanent Representation.

2. Starting auction price.

The starting auction price is set at € 14,876.03 (fourteen thousand eight hundred seventy-six/03). The starting auction price is determined on the basis of an independent appraisal, which may be consulted by potential purchasers upon request at the email address: cont.natobruxelles@esteri.it.

3. Method of sale.

a) The auction will be conducted through the submission of sealed bids equal to or higher than

the starting auction price.

- (b) Bids must be received by this Permanent Representation in a sealed envelope bearing the wording: "Vehicle offer".
- (c) Subject to the provisions of the general conditions, the auction will be declared void if at least one valid bid is not submitted.

4. Participation deadline.

To participate in the auction, interested parties must submit their bid, under penalty of exclusion, no later than 19/01/2026.

Bids must be submitted **exclusively** by registered mail to the following address:

The date of dispatch of the registered mail shall be irrelevant. In all cases, the date recorded by the NATO Offices' security check receipt shall prevail.

5. Contents of the bid.

The bid must be placed inside a single package, sealed and countersigned on the closing flaps. The package must bear the name of the sender and the wording "DO NOT OPEN – Auction for the purchase of AUDI A6 vehicle".

The package must include two sealed envelopes, also sealed and countersigned on the closing flaps, each containing the documents listed below:

ENVELOPE NO. 1: The envelope must bear the wording "DO NOT OPEN – Application to participate in the auction". The envelope must contain:

- the application to participate in the auction, drawn up in accordance with the template attached to this notice under letter "A" ("Annex A"), duly signed;
- the declaration of possession of the requirements referred to in the previous Article 3, drawn up in accordance with the template attached to this notice under letter "B" ("Annex B"), duly signed;
- a photocopy of a valid identity document;
- if the application is submitted by an authorized representative, the document attesting to such powers.

It is specified that any formal errors, or the omission of even a single declaration required in the application to participate, will result – at the verification stage – in the exclusion of the bid.

ENVELOPE NO. 2: The envelope must bear the wording "DO NOT OPEN – Financial offer for public auction". The envelope must contain the financial offer, drawn up in accordance with the template attached to this notice under letter "C" ("Annex C"), duly signed.

The financial offer must indicate the price offered for the purchase of the vehicle.

The amount must be written in figures and in words. In the event of a discrepancy between the amount stated in figures and that stated in words, the amount more favorable to the Administration shall prevail for the purposes of awarding the contract, pursuant to Article 72, paragraph 2, of Royal Decree No. 827 of 23 May 1924. No other documents may be included in the envelope.

6. Inadmissibility of proxy bids.

Proxy bids are not permitted, except in the case of legal representatives of public and private legal entities and companies engaged in business activities.

7. Public session for opening of bids.

The Evaluation Committee will proceed with the opening of the envelopes on 21 January 2026 at 11:00 a.m., in a public session open to bidders who have submitted an offer. For security reasons related to access restrictions to NATO Headquarters, by way of derogation from ordinary provisions, access to the Offices of the Permanent Representation will require the submission of a written request, attaching a valid identity document, to the following address: cont.natobruxelles@esteri.it.

The Permanent Representation reserves the right to modify the date of the session, providing timely notice through publication of an announcement on the institutional website or by email to the address indicated in the application to participate.

8. Award procedure.

The auction shall be deemed valid and the Permanent Representation may proceed with the award even in the presence of only one valid offer.

If two or more bidders present at the auction submit the same offer, a further bidding round shall be held in the same session among those bidders only, by means of sealed bids. Each increase shall be set at a minimum of \in 100.00 (one hundred/00). Each increase shall be deemed an irrevocable offer.

If no bidder is present, or those present do not wish to improve the offer, or only one party is present, the award shall be made by drawing lots pursuant to Article 77 of Royal Decree No. 827 of 23 May 1924.

The offered price must be equal to or higher than the starting auction price. Offers below this amount will not be accepted. The results of the auction procedure will be published on the Representation's website: rappnato.esteri.it.

9. Effects of the award report.

The award report shall not have the effects of a contract of sale; therefore, it will be necessary to proceed with the execution of the deed of sale in accordance with the provisions of the following Article 9.

10. Execution of the contract and payment of the price.

La The Permanent Representation will notify the interested party of the award and will transmit the deed of sale for countersignature. The same communication will provide instructions regarding the payment method.

The execution of the deed of sale and payment of the price must take place within 20 working days from the date of notification of the award.

If the successful bidder fails to countersign the contract and/or pay the price within this time

limit, the Permanent Representation reserves the right to revoke the award and to contact the other unsuccessful bidders, if any, following the ranking order.

11. Conditions of sale.

The above-mentioned vehicle is sold in its current state of fact and law. The vehicle will be made available immediately upon signature of the contract of sale.

12. Waiver by the purchaser.

In the event of waiver or if the final successful bidder fails to appear for the execution of the deed of sale within the communicated time limit, they shall forfeit all rights. In such a case, the Permanent Representation reserves the right to consider awarding the asset to the second highest bidder or to initiate a new procedure.

14. Processing and storage of data.

For the submission of expressions of interest, proposers are required to provide data and information relating to their representatives and/or employees, which fall within the scope of application of EU Regulation 679/2016 ("GDPR") and Legislative Decree No. 196 of 30 June 2003, as amended and supplemented.

The processing of personal data will be carried out in compliance with the applicable legislation, in accordance with the information notice provided to this Administration pursuant to Article 13 GDPR and attached to this notice under letter "D" ("Annex D").

15. Publication.

This notice, which will remain published until 19/01/2026, will be posted on the notice board of the Permanent Representation of Italy to the Atlantic Council and published on the same day on the official website (https://rappnato.esteri.it/) in the "Transparent Administration" section.

16. Jurisdiction.

In the event of disputes, the competent court with exclusive jurisdiction shall be that of Brussels.
