



**DECLARATION ORDER OF TENDER UNSUCCESSFUL  
RELATING TO THE SECOND NOTICE OF SALE OF A USED VEHICLE,  
AUDI A6 2.0 TDI ULTRA**

Having regard to the Italian Royal Decree No. 2440 of 18 November 1923, laying down “New provisions on the administration of State assets and on general State accounting”;

Having regard to the Italian Royal Decree No. 827 of 23 May 1924, laying down the “Regulation for the administration of State assets and for general State accounting”;

Having regard in particular to Articles 73(c) and 76 of the Italian Royal Decree No. 827 of 23 May 1924, as amended;

Having regard to the Italian Presidential Decree No. 18 of 5 January 1967, “Organisation of the administration of foreign affairs”;

Having regard to Italian Law No. 241 of 7 August 1990, “New rules on administrative procedure and the right of access to administrative documents”;

Having regard to the Italian Presidential Decree No. 54 of 1 February 2010, “Regulation laying down rules on the managerial and financial autonomy of diplomatic missions and first-category consular offices of the Ministry of Foreign Affairs”;

Whereas, by the Italian Presidential Decree No. 16 of 24 June 2025, Ambassador Alessandro Azzoni was appointed Permanent Representative of Italy to the North Atlantic Council at this Mission, with effect from 15 September 2025;

Whereas, by Service Order No. 104 of 29 September 2025, Deputy Commissioner Dr. Gabriele Di Palma was appointed Sector Coordinator;

Whereas, by Message DGAI – Office I, ref. No. 216204 of 27 November 2025, the Permanent Representation was authorized to sell by public auction, pursuant to Article 37 of the Italian Royal Decree No. 827 of 23 May 1924 and MAECI Circular No. 9 of 7 August 1998, the service vehicle Audi A6 2.0 TDI ULTRA, registration number CDAK556;

Whereas furthermore, as prescribed by the above-mentioned Message, the service vehicle was assessed by a specialized company in the sector, DEKRA Belgium NV, resulting in a valuation of EUR 14,876.03;

Having regard to the Decree of the Permanent Representative No. 9/2025, initiating the auction sale procedure of the above-mentioned service vehicle, with the Head of Procedure identified as the Coordinator of the Administrative Sector, Dr. Gabriele Di Palma;

Having regard to the notice of auction sale, published on the institutional website of the Permanent Representation to the North Atlantic Council on 19 December 2025, with a deadline of 19 January 2026;

Having regard of the notice of failed auction of 26/01/2026;

Whereas, with DGPA Message – Office I n. 25843 of 09/02/2026, the Permanent Representation was authorized to initiate a second attempt at a public auction, with a reduced starting bid, within the terms indicated in paragraph 9 of art. 65 of the R.C.G.S. 23 May 1924 n. 827;

Having regard of Decree no. 2/2026, which ordered the initiation of the procedure for the second public auction for the sale of the service car;

Having regard of the notice of the second auction, published on 09/03/2026, with a deadline on 08/04/2026;

Noting that, within the deadline set by the Notice, no bids were received;

**HEREBY DECLARES**

1. to acknowledge that, by the final deadline for the receipt of bids for the second public auction procedure for the sale of the used motor vehicle Audi A6 2.0 TDI ULTRA, set for 8 April 2026, no bids were received;
2. to declare the second public auction for the sale of the service vehicle of the Permanent Representation unsuccessful;
3. to give due publicity to this decision.
